Ready-to-use liquid iodophor-based teat disinfectant



Ready-to-use iodophor formulation, specially formulated to help reduce the risk of infection. Effective aid in the control of mastitis in dairy herds.

Leaves an antiseptic layer of iodine adhering to teats after dipping or spraying.

Passes EN 1656. Helps to reduce bacterial contamination that causes mastitis in dairy herds.

DIRECTIONS FOR USE:

This product must be brought to a temperature above 20°C before use. Use undiluted. The use of a dosing pump for filling application equipment is recommended. Ensure udder and teats are clean and dry before using this product.

MANUAL DIPPING/FOAMING:

Fill teat cup $\frac{2}{3}$ full with product. Dip the teats of each cow immediately after each has been milked, making sure that the full length of the teat is immersed. Top up with fresh solution as required.

Empty and wash out cups with water after milking.

To ensure sufficient contact time, care should be taken that the product is not removed after application (e.g. keep the cows standing for at least 5 minutes).

SPRAYING USING AN ELECTRONIC SPRAYER:

Immediately after milking, spray the teats of each cow with product. Ensure the spray covers the entire surface of all teats.

To ensure the product is not removed after application (e.g. keep the cows standing for at least 5 minutes).

After use dispose of unused product, the packaging and any contaminated materials in accordance with local requirements. Used solutions can be flushed to the municipal sewer or disposed to the manure deposit depending on local requirements. Avoid release to an on-site wastewater treatment plant.
