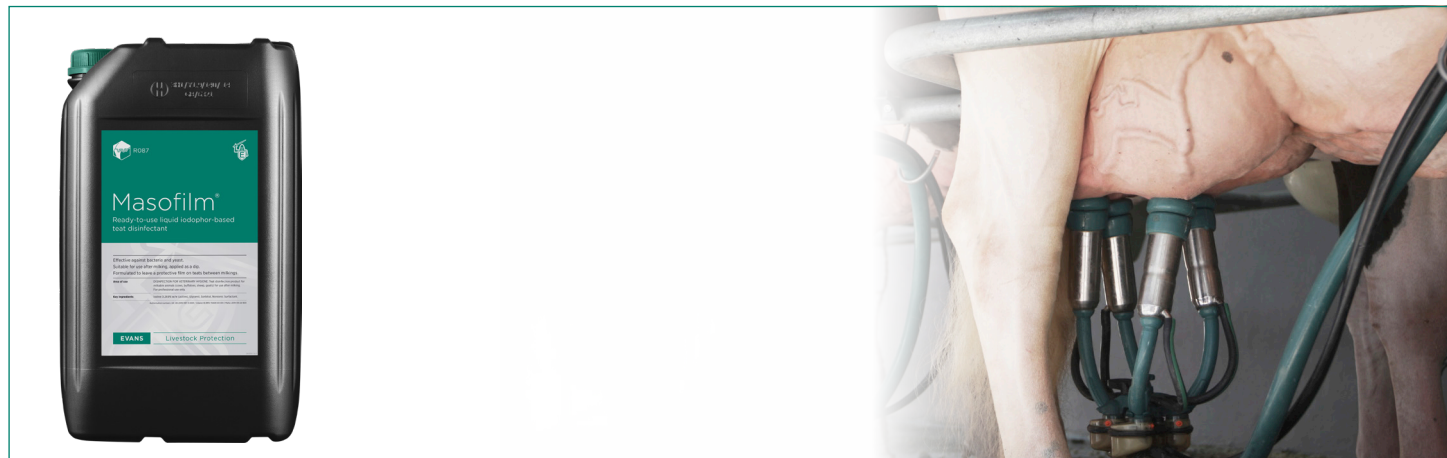


# Masofilm®

## Ready-to-use liquid iodophor-based teat disinfectant



Highly effective iodophor barrier film which provides long lasting protection between milkings.

Forms a protective barrier film on the skin which will remain in place for up to 12 hours.

Lower surfactant levels and higher emollients to give excellent teat condition.

- Contains 0.269% w/w available Iodine and 10% glycerol & sorbitol.
- Added polymers for excellent filming properties.
- Gives teat-end barrier protection between milkings.
- Not suitable for use through any type of sprayer.
- Ready-to-use, especially suitable for situations where measurement and mixing are likely to prove inconvenient.

For post-milking use only.

This product must be brought to a temperature above 20°C before use.

Use undiluted.

The use of a dosing pump for filling application equipment is recommended.

Ensure udder and teats are clean and dry before using this product.

#### MANUAL DIPPING:

Fill teat cup  $\frac{2}{3}$  full with product.

Dip the teats of each cow immediately after each has been milked, making sure that the full length of the teat is immersed.

Top up with fresh solution as required.

Empty and wash out cups with water after milking.

To ensure sufficient contact time, care should be taken that the product is not removed after application (e.g. keep the cows standing at least 5 minutes).

After use, dispose of unused product, the packaging and any contaminated materials in accordance with local requirements. Used product can be flushed to the municipal sewer or disposed to the manure deposit depending on local requirements. Avoid release to an on-site wastewater treatment plant.
