A153 is a Cosmetic Product which contains: Aqua, Sodium Laureth Sulfate, Sodium Chloride, Cocamide DEA, Glycerin, Parfum, Benzyl Alcohol, Chloromethylisothiazolinone, Methylisothiazolinone, Triethylene Glycol, Propylene Glycol, Magnesium Chloride, Magnesium Nitrate, CI 16035, CI 18965.

4.1. Description of first aid measures
